1. FINANCIALS

A. MASTER BOARD BUDGET WORKSHOP FOR 2026

- a. **Clubhouse-tentative 2026** increase \$0.00 per home per month!!! (remains \$129) *In 2008 (when residents purchased the clubhouse, dues were \$101.00 per house per month.) From 2008 to 2026, if this budget is approved, Clubhouse Assessments averaged an increase of \$1.76 per month per year. Increased \$28.00 over 17 years.
- *Since 2008 we replaced air conditioners, went through a roof collapse, restored the ballroom, refinanced the Clubhouse Mortgage twice, at lower rates, expanded and renovated the East Wing, renovated the sports courts, installed pavers at the pools and front entrance, replaced the pool furniture, remodeled the interior of the North Spa, kitchen and the main lobby, renovated the main clubhouse restrooms, re-milled the clubhouse and No. Spa parking lots, and replaced the carpets, lights and chairs in the ballroom, improved the ventilation at the North Spa and replaced the trees in the Clubhouse parking lot.
- *The Mortgage will be paid in full in October 2029.
 - b. **Kings Ridge Community Association-tentative** increase \$4.00 per home per month! (\$101).
- *In 2009 dues were \$67.00 per house per month. From 2009 to 2026, if this budget is approved, KRCA Assessments averaged an increase of \$1.80 per month per year. Increased \$34.00 over 18 years.
