Kings Ridge has 127 street lights that we have been paying a maintenance fee of \$5.45 per month or \$8303 annually, plus electric usage for all the poles.

Beginning

October 1, 224, the rate will go to \$17.36 per month per pole or \$26,462 annually. October 1, 2026, the rate will increase to \$34.73 per month or \$52925 annually for

all poles.
